Financial Fitness Report

A second strong investment market year resulted in a fiscal year ending balance of \$881,748 with net worth growth of \$112,335, year-over-year.

Your alumni foundation received \$7,372 in donations. It gained \$190,440 from investment sales, dividends, or capital gains as well as \$69,509 of appreciation. Alternately, it awarded \$36,001 in UW scholarships, made investment purchases of \$113,483, and incurred \$5,501 in operating expenses. These last expenses continue to be less than 1% percent of our fiscal year beginning balance and just .62% of our ending balance.

The success of maintaining volunteer oversight of our organization results in more dollars available for our scholarship purpose. Our tax accountant, taxes and annual report costs represent the greatest expense.

It will be through expanded online communications and a succession of volunteers that Mortar Board Alumni/ Tolo Foundation will maintain such an enviable position. Your time and gifts will always be something for which the organization is ever grateful!

Barb Graff: Keynote Speaker

Imagine the possible scale! Imagine the circumstances...

Barb Graff is Director of the City of Seattle's Office of Emergency Management. Her responsibilities include managing the multi-hazard interdepartmental emergency management program for the City of Seattle and coordinating its relation to other emergency response agencies and community groups. The program encompasses all phases of integrated emergency management including preparedness, mitigation, response and recovery.

Ms. Graff has been the Seattle Director since June of 2005. A graduate of the University of Washington, she served in a similar capacity for the City of Bellevue for 21 years. Under her leadership, Bellevue's emergency management program served as the pilot for the national Emergency Management Accreditation process.

She has managed the response to a number of Presidentially declared disasters and has a depth of experience with full-scale and functional exercises.

She currently chairs the national Emergency Management Program Review Committee and serves on the Emergency Management Accreditation Commission.

Regionally, she serves on the King County Advisory Committee on Emergency Management and Regional Homeland Security Council.

Honoring the Golden Class of 1965

This year's Golden Class experienced their collegiate senior year when the nation faced dramatic issues. Shortly before classes began in the fall, Congress passed the Gulf of Tonkin Resolution, which led to the massive military conflict of the Vietnam War. Civil rights became a major focus of the country during the Class of 1965's senior year. Martin Luther King, Jr., inspired a movement and received the Nobel Peace Prize. LBJ signed the Voters Rights Act into law in 1965. Campus unrest became widespread as civil rights and antiwar demonstrations grew. The era had lighter moments, as well. The Beatles' music and film Hard Day's Night, and the film Mary Poppins soared in popularity, for example.

Members of the Class of 1965 established a distinguished record of contributions on national, regional, and local levels. They have made differences.

Tolo Foundation Scholars Excel

Outstanding University of Washington students were selected from a highly competitive field of candidates to be 2014/2015 Mortar Board Alumni/Tolo Foundation Scholars. Two of the 14 Scholars are Mortar Board actives (*).

The Foundation awarded a total of \$42,000 in scholarships for this academic year. Scholarships ranged from \$2,500 to \$3,500. (Foundation scholarship names are in parentheses.) Named scholarships are the result of significant gifts honoring or memorializing esteemed Mortar Board alumni.

Dashni Amin, senior; Philosophy, Law, Societies, Justice (Heritage, honoring Cassie Bryant/Florence Wiltsie/Carrie Cowgill-Thompson). An early entrant to UW, Dashni will receive in June her bachelor's degree with college honors and a minor in Philosophy. She hopes to better the legal and social condition of women in the Muslim world.

Kainen Bell, senior; Business Administration, Social Welfare (Arnold and Carolyn Bryant Peterson). Kainen plans to pursue a Ph.D. researching intersections between corporations and communities, particularly researching corporate philanthropy and the best methods of giving back.

David Alexander Boeckh, sophomore; Music Performance (Music Performance/Arnold and Carolyn Bryant Peterson). Majoring in Organ Performance, David aims for a career as a church musician and performer. He hopes to increase the public's awareness and appreciation of the pipe organ's rich history and sound capabilities.

Tribute to Margery Phillips

It is with great sadness that we announce the passing, at the age of 97, of Mortar Board/Tolo alumna Margery R. Phillips, a University of Washington graduate and founder of the Margery R. Phillips Scholarship. Her scholarship is awarded to an outstanding student in Architecture through the Mortar Board Alumni/Tolo Foundation scholarship program.

Margery was one of the most extensively published local architectural writers. As a *Seattle Times* journalist and editor, she was instrumental in establishing the Seattle Times-AIA Home of the Month program in 1953, the first of its kind in the country, with the organization then known as the Washington State Chapter of the American Institute of Architects (now AIA). Margery continued writing monthly features for the first two decades of the program.

In appreciation of her many outstanding contributions to architecture, Margery was made an honorary member of AIA. Margery also devoted her time to many community organizations, including Children's Orthopedic Junior Board, the University of Washington Alumnae Board, the Northwest Horticulture Board, and both the King County Landmarks Commission and the Washington State Board for Historic Preservation, and others,

Many University of Washington students have benefited and will continue to benefit from the scholarship which Margery established.
